Dear President Couzner and Members of the General Assembly,

It is my intention to seek nomination for the position of Vice President to World ParaVolley, a position that will be elected at the WPV General Assembly to be held virtually on 4th December 2022.

After serious discussion with you and outgoing Vice President, Wayne Hellquist (CAN), and careful consideration with encouragement from other members of the Board, I reached this decision. As allowed, I will remain a candidate for the position of Sport Director as nominated by the Board in September until an election result is confirmed by the General Assembly.

I am fully engaged in my current role as the WPV Sport Director which has been a brief period of service to finish out the term of my predecessor. I have identified areas of our organization where my professional skills and career expertise can contribute to the forward growth of World ParaVolley in this short time period. I am focused on the beginning of building a new system for the WPV Sport Department, and to provide others with opportunity for advancement including Isabelle Collot (FRA) Assistant Sport Director for sitting volleyball and Dr. Stephen Giugni (AUS) Assistant Sport Director for beach ParaVolley.











I am confident the Sport Department and those volunteers now working in it will continue to develop under the collective leadership of the Assistant Sport Directors of Sitting Volleyball and Beach ParaVolley, the related commissions, and the team of Zone Sport Directors in the working group I established to achieve greater representation for our Zones. I continue to recruit individuals to serve as technical officials from around the world (particularly Africa and Asia Oceania) and raise the profile of diversity and inclusion as well as gender equity within WPV. If successful in the effort to become the next WPV Vice President, I intend to continue supporting the Sport Department, all Directors and commissions to continue building capacity and human resources related to our strategic plan and succession planning.

- 2.) and extensive experience in all areas of governance serving for international and domestic sport federations, non-profit associations, and international corporations dealing specifically

- 3.) Recent work in governance and safeguarding including restructuring international federation infrastructure, executive management recruitment, development of new event and marketing properties. Expertise to connect global agencies to increase capacity and access to additional resources.
- 4.) Experience in organizing and leading strategic planning, especially for international and domestic sport federations. Project management experience including facilitation and implementation stages.
- 5.) Developed strong relationships with key heads of sport federations, diplomats, and primary contacts globally through volunteer positions held with respective federations or associations. Extensive experience working with international sports, media (digital, broadcast, print), and marketing professionals including high-level interaction and negotiation with key stakeholders.
- 6.) Recent work to promote Paralympic and adaptive sport, particularly in the Los Angeles (USA) area through the Angel City Games, the LA84 Foundation / Play Equity Project, and the 2028 Los Angeles Olympic & Paralympic Organizing Committee and PlayLA legacy projects.

The honor of serving as Vice President to WPV's Board of Directors is a way for me to impact the future of the organization through the action of giving back. Finding ways to bring additional resources into our community is a worthwhile challenge in my eyes. Thank you to the Board for the nomination as Sport Director, and for the encouragement and consideration of my eligibility for the position of Vice President.
