3 Agenda Items

- The President delivered a paper entitled "Where have we been since 2018?" as a summary of Board issues and future considerations
- The Athletes' Commission spoke about issues of concern such as event planning, recruiting past athletes, communications and classification

- The Marketing Director delivered a paper about "The Business of Sports" with a focus on the WPV Foundation, WPV structure and the need to register "World ParaVolley" in the USA
- ParaVolley Europe addressed the topic of "Digitisation" and how this was used on the Zone for competition management
- The Marketing Director spoke about "Branding" and the need to protect our name and discipline names
- The Sport Director delivered a paper about the 2028 Paralympic Games in LA, competitions, ITOs, Safeguarding, Per Diem Policy and a competition management system
- The Medical Director delivered a paper about Anti-Doping, Classification, and Online Education
- The Development Director delivered a paper about the Coaches Commission, Courses, Development Centres, VolleySLIDE, Grant funding and Molten
